

# SCULPTURE IN THE PARK 2012

SCULPTURE IN THE PARK, heralded as one of the finest outdoor juried exhibitions of three-dimensional artwork in the United States, will be held **August 11-12, 2012**, in Loveland's **Benson Sculpture Garden**. Sponsored by the Loveland High Plains Arts Council (LHPAC), the **29th Annual Show** will host 175 of the finest sculptors from around the world. Each year, this outstanding exhibit attracts thousands of art lovers and collectors from across the country. Sales at the show now exceed \$1,000,000, with approximately three-fourths of the artists selling their work.

The **2012 Call for Entries** welcomes applications from new and previous exhibiting artists. **Sculpture in the Park** endeavors to diversify and enrich each show by featuring a wide range of artistic expression.

## CALL FOR ENTRIES



### POLICIES

- ▼ The show is open to sculptors working in permanent media. Approximately 175 sculptors will be chosen to participate in Sculpture in the Park 2012.
- ▼ A \$100 artist fee is due upon acceptance into Sculpture in the Park.
- ▼ Entrants must display a minimum of six and a maximum of eight pieces.
- ▼ LHPAC takes a 33.3% commission on all sales.
- ▼ The show provides tents and pedestals and manages all sales.
- ▼ LHPAC reserves the right to invite a limited number of artists to participate without having to submit to the jurying process.

### ENTRIES

- ▼ Complete and return application form by January 20, 2012. Include a \$35 nonrefundable application fee. Make checks payable to LHPAC.
- ▼ Submit four digital images on a CD of four different pieces of sculpture with only one image per piece. The artist's picture or name should not appear in the image.
- ▼ Each piece submitted must have been created within the last three years.
- ▼ Submission constitutes agreement by the applicant to conditions specified in the prospectus. LHPAC reserves the right to final curatorial decision. If accepted, work displayed at the show must be representative of juried work.

### CD DIGITAL IMAGE GUIDELINES

- ▼ Image size: 4x5 not to exceed 1 MB.
- ▼ File format: .jpeg or .jpg
- ▼ Image Identification: Please mark your image file A, B, C, or D so it corresponds with the application information. Your name must be written on the CD.  
**NOTE:** Only digital images on a CD will be accepted. Failure to comply with the above digital guidelines will result in the return of the artist's application. We **CANNOT** accept applications via email.

### IMPORTANT DATES

- ▼ **Jan. 20, 2012:** Deadline for call for entry.
- ▼ **Week of Feb. 27, 2012:** Notification of acceptance or rejection for Sculpture in the Park.
- ▼ **Aug. 9, 2012:** Artist set-up day.
- ▼ **Aug. 10, 2012:** Patron Party for the 29th Annual Show.
- ▼ **Aug. 11-12, 2012:** 29th Annual Sculpture in the Park.
